## Foreword

At the sixty-first Annual Reunion of the Skilton Family held August 18, 1926, at Watertown, Connecticut, the officers of The Doctor Henry Skilton Association were instructed to proceed at their discretion with the publication of a Supplement to the family genealogy: "Doctor Henry Skilton and His Descendants". To provide the necessary funds the Treasurer of the Book Committee was authorized to turn over to The Doctor Henry Skilton Foundation the balance of \$59.95 remaining in his hands, and empowered to augment this fund by such further money as might be required, to be raised by the sale of additional books.

The officers of The Association deemed the amount of data available sufficient to warrant proceeding at once with the preparation and printing of Supplement I.

In considering the appointment of an Editor it was perhaps natural that thought should turn to John Davis' Skilton, who edited "Doctor Henry Skilton and His Descendants". While willing to serve the Family in any capacity, and quite ready to aid in the preparation of material for this Supplement, John Davis' Skilton requested that the privilege of editorship be accorded to the former Registrar, and to his successor, into whose hands were to be placed the official genealogical records of the Family.

Further, coming into being through the labors of The Association, and being facilitated by the funds of the Family, it was felt that this Supplement should be edited jointly by a representative of The Association and of the Family.

Accordingly, the Editors were selected by the officers of The Association.

Briefly stated, the purpose of the Supplement is to assemble and publish in permanent form such material as will bring up to date, i. e., May 1, 1927, the salient points of the story of the Skiltons along the lines adopted in the original publication.

The pagination of this Supplement is based on that of the original volume, the first page hereof being numbered 413, following in sequence the last page of that book.

The information in the Addenda, page 378, has been incorporated herein. The Explanatory Note, page 9, applies in all particulars to the Supplement. To abbreviations, add opp.—opposite; q. v. — refer to which.

Grand Numbers for those first mentioned in the Addenda, page 378, or in this Supplement, are thus composed:

Using the Grand Number of the individual's parent as found in "Doctor Henry Skilton and His Descendants" an S is prefixed thereto, signifying that the Grand Number is first em-

ployed in Supplement I. To this number is then affixed an Arabic numeral designating the ordinal number of the child in the family of the parent who is a descendant of Dr. Henry<sup>2</sup> Skilton.

If both parents of a child are descended from Dr. Henry<sup>2</sup> Skilton, the child's Grand Number is based on that of the father.

S 784-2 ii designates Edward Karl<sup>8</sup> Skilton, son of 784 George Warner<sup>7</sup> Skilton (see page 378) and is thus explained:

The S signifies that the Grand Number is first employed in this Supplement. 784 is the Grand Number of George Warner<sup>7</sup> Skilton, father of Edward Karl<sup>8</sup> Skilton, which is used rather than that of the child's mother, 816 Lora Agnes<sup>7</sup> (Skilton) Skilton. The Arabic 2 following 784 indicates that Edward Karl is the second child of his father.

The index to this Supplement contains the names of all persons mentioned herein. The first page reference is the index page to "The Cyclopeedy" on which such name occurs.

The Editors of the Supplement take this opportunity to voice their appreciation for the aid and advice given them by the living members of the former Publication Committee, particularly to Dr. John Davis<sup>7</sup> Skilton, Carrie May<sup>6</sup> (Skilton) Skilton and Charles Herbert<sup>7</sup> Skilton. Due credit and appreciation are also extended to all who have in any way aided the Editors in securing genealogical data, for without such aid the Supplement could not have been published.

### **The Cyclopeedy**

Eugene Field published one of his delightful and highly amusing Profitable Tales under the title: "The Cyclopeedy". The story is of a young couple, who, soon after their marriage, wishing to start aright, subscribe for an encyclopedia — they call it "The Cyclopeedy" — which they agree to take and pay for, a volume at a time, as it comes from the press. The usual delays, delivery at inopportune times and the other vexations incident to such a transaction are set forth in entertaining fashion. Finally, after the lapse of many years, when the woman is dead and gone, and the man has grown old and feeble, the last volume is delivered to him on his death bed. He clutches the book and pays the agent for it, just as his soul flees from its mortal tenement and soars "rejoicin' to realms of everlastin' bliss". The poor old man passes away unaware that his estate is liable for the index, as yet unpublished, and still to come, this information being imparted to the heirs, gathered in the chamber of death, by the agent for "The Cyclopeedy".

While the book "Doctor Henry Skilton and His Descendants" was in course of preparation many delays and discouragements

were encountered. The World War was fought; prices rose to unprecedented heights; unnecessary printing was restricted; some members of the Publication Committee were engaged in war work; impediments of one sort and another combined to postpone the printing of the book, causing the Editor, well nigh in despair, to dub the Skilton Family book: "The Cyclopeedy", after the publication immortalized in Field's story of high hopes and pleasant anticipations which were realized only after many trials and tribulations. So it was that "Doctor Henry Skilton and His Descendants" came to be known among those descendants as "The Cyclopeedy".

We venture the opinion and we express the hope that the name will abide, as it epitomizes much of labor, of hope deferred, of keeping everlastingly at it and of final achievement, all in the face of hindrances and discouragements which have endeared to us the name and the reality of "The Cyclopeedy".

### **The Doctor Henry Skilton Foundation**

"The Cyclopeedy" was completed and issued in 1921, and, at the Reunion in 1925, ten years after the publishing of the family book had been authorized, the Book Committee reported that all of its financial obligations had been discharged.

One undertaking had enlisted the interest and co-operation of the Family during a decade, and had been carried to completion. It therefore seemed desirable and fitting that there should be inaugurated another enterprise upon which endeavor might be put forth with resultant benefits to many people for a long time to come, to say nothing of the cohesion and stimulus of a common ideal constantly afforded to the living.

A brief account is given of the establishment of The Doctor Henry Skilton Foundation, brought about by the hope of the members of the Clan to perpetuate worthily Dr. Henry<sup>2</sup> Skilton's memory, by their desire to render service to others and by their sense of loyalty each to the other, inspired by a common ancestry.

At the Preliminary Gathering of the Family, held June 20, 1925, it was moved that a committee be appointed to consider the establishment of a Fund in memory of Dr. Henry<sup>2</sup> Skilton, the committee to report at the Sixtieth Reunion. The committee consisted of:

At the sixtieth Reunion, August 19, 1925, a report was made recommending the establishment of such a Fund and the appointment of a Board of Trustees, to report more fully at the next Preliminary Gathering.

The Trustees reported at the Preliminary Gathering held June 12, 1926, and the following Articles of Association were adopted:

## **“The Memory of the Just is Blessed”**

### **Preamble**

Whereas, Doctor Henry Skilton was an accomplished physician and surgeon, a preacher of righteousness, a devoted patriot, a surgeon and chaplain in the army of the American Revolution which achieved the independence of the United States, a man of exalted Christian character and of notable achievement, God fearing, honest and honorable, sustaining well every relation throughout a long and useful life, worthy of our pride and emulation, and

Whereas, His wife, Tabitha (Avery) Skilton, was an helpmeet for him,

Now therefore be it resolved:

That to perpetuate in worthy manner the memory of these our ancestors by the performance of helpful offices for those who may be of their posterity and for the accomplishment of good things for our fellow men, we, descendants of Doctor Henry Skilton and his wife, Tabitha (Avery) Skilton, appreciative of our heritage, do form The Doctor Henry Skilton Association for the purpose of establishing The Doctor Henry Skilton Foundation, devoting thereto certain moneys already given for its purposes, pledging that we ourselves will maintain The Doctor Henry Skilton Association and The Doctor Henry Skilton Foundation and that we will enjoin upon our descendants the privilege and duty that will be theirs, as well as our own, in safeguarding and increasing The Doctor Henry Skilton Foundation and administering it under the provisions of the following Articles of Association for the accomplishment of the purposes set forth herein.

**Articles of Association**  
**of**  
**The Doctor Henry Skilton Association**  
**The Association**

<i>Name</i>	The name of this organization shall be The Doctor Henry Skilton Association, hereinafter referred to as THE ASSOCIATION.
<i>Members</i>	The members of THE ASSOCIATION, hereinafter called the members, shall be those descendants, as hereinafter defined, and those persons wedded to descendants of Doctor Henry Skilton and his wife, Tabitha (Avery) Skilton, who shall from time to time subscribe to these Articles of Association in a book or on cards provided for that purpose and kept by the Secretary. No member who has not attained the age of eighteen years shall be entitled to vote upon any measure affecting or concerning the election of officers, or other business of THE ASSOCIATION.
<i>Effective</i>	These Articles of Association shall become effective when twenty-five members entitled to vote shall have subscribed to them.
<i>Quorum</i>	A quorum for the transaction of business at any meeting of THE ASSOCIATION shall consist of fifteen members entitled to vote.
<i>Preliminary Gathering</i>	The term "Preliminary Gathering" employed in these Articles of Association shall be understood as designating and referring to the Preliminary Gathering of The Skilton Family usually held in the month of June of each year.
<i>Annual Reunion</i>	The term "Annual Reunion" employed in these Articles of Association shall be understood as designating and referring to the Annual Reunion of The Skilton Family usually held in the month of August of each year.
<i>Descendant</i>	The terms "descendant" or "descendants" employed in the foregoing Preamble and in these Articles of Association shall be understood as designating and referring to those who are descended from Dr. Henry Skilton and his wife, Tabitha (Avery) Skilton, exclusively through and from their son, Avery Skilton, and his wife, Parthenia (Judd) Skilton, except that these terms shall include any person or persons who

shall have been legally adopted by any descendant or descendants as defined herein.

*Purposes*

The purposes of THE ASSOCIATION shall be:

- (a) To establish The Doctor Henry Skilton Foundation, hereinafter referred to as THE FOUNDATION;
- (b) To raise, augment, safeguard, invest and reinvest the moneys of THE FOUNDATION;
- (c) To buy and sell real estate on account of THE FOUNDATION;
- (d) To administer THE FOUNDATION and its affairs for the purposes and in the manner set forth in these Articles of Association;
- (e) To undertake such projects and activities as THE ASSOCIATION may elect.

*Charter*

THE ASSOCIATION may seek a charter and be incorporated under the laws of The United States of America or of any State of the Union for the furtherance of the purposes for which THE ASSOCIATION is formed and maintained.

### **The Foundation**

*Purposes*

The purposes of THE FOUNDATION shall be, subject to the provisions and terms of these Articles of Association:

- (a) To perpetuate in any appropriate manner the memory of our ancestors, Doctor Henry Skilton and his wife, Tabitha (Avery) Skilton, whom we have ever been taught to respect and to revere;
- (b) To supply, erect and maintain objective, tangible memorial, or memorials, to Doctor Henry Skilton or his wife, Tabitha (Avery) Skilton, or both, at the times, in the places and in the manner which THE ASSOCIATION may elect;
- (c) To accomplish helpful offices and ministrations in behalf of any descendant of Doctor Henry Skilton and his wife, Tabitha (Avery) Skilton;
- (d) To render such altruistic service as may from time to time commend itself to THE ASSOCIATION, as opportunity or necessity may determine.

### The Board of Trustees

- Duties* THE FOUNDATION shall be under the direction of a Board of Trustees, hereinafter referred to as the Board, which shall consist of fifteen members, and which shall have oversight and control of all property, real, personal and mixed, of which THE FOUNDATION may at any time be possessed, subject to the provisions of these Articles of Association.
- Rules* The Board shall adopt rules for its procedure which shall conform to the provisions of these Articles of Association.

### Officers

- Names* The officers of THE ASSOCIATION and of the Board shall be the same and shall be a President, a Vice President, a Secretary and a Treasurer, all of whom shall serve for a period of one year, or until their successors shall be elected.
- Election* These officers shall be elected by THE ASSOCIATION at the time of the annual election of Trustees, and subsequent to such election.

### Duties

- President* It shall be the duty of the President to preside at all meetings of the Board, to call meetings of THE ASSOCIATION and of the Board when necessary, or advisable and to preside at all called meetings. He shall be ex officio a member of all committees appointed by the Board. He shall appoint all standing committees and Auditors. In his absence and that of the Vice President a president pro tempore shall be appointed to preside over any meeting of THE ASSOCIATION or of the Board which may be held in accordance with these Articles of Association.
- Vice President* In the absence of the President, it shall be the duty of the Vice President to preside at the meetings of the Board and at all called meetings. During the disability of the President his duties shall be discharged by the Vice President.
- Secretary* It shall be the duty of the Secretary to make and keep complete records of the votes, doings and proceedings of the meetings of THE ASSOCIATION and of the Board, which records shall be open at all reasonable times to the inspection of members of THE ASSOCIATION. He shall

provide and keep the book wherein are inscribed these Articles of Association. He shall keep the signatures of the members, either in such a book, or upon cards provided for that purpose. He shall receive and keep on file written copies of all reports of officers and committees. He shall be ex officio a member of all committees appointed by the Board and of all standing committees. He shall transmit all notices of meetings as required by these Articles of Association.

The Secretary shall receive and keep an accurate record of all moneys and securities contributed to, acquired by, or designated for THE FOUNDATION and all income of THE FOUNDATION of every sort and kind and shall pay the same to the Treasurer promptly, taking his written receipt therefor. He shall advise the Treasurer in writing of all disbursements of moneys authorized and ordered in accordance with the provisions of these Articles of Association. At the time of the Annual Reunion, he shall make to THE ASSOCIATION a written report of the acts and affairs of THE ASSOCIATION for the preceding fiscal year.

*Treasurer*

It shall be the duty of the Treasurer to receive from the Secretary, giving his written receipt therefor, all moneys and securities belonging to THE FOUNDATION, howsoever acquired, and to enter regularly in books provided and kept for that purpose all moneys received and disbursed on account of THE FOUNDATION. He shall deposit all moneys belonging to THE FOUNDATION in a depository or depositories chartered by The United States of America, or by any State of the Union, and approved by the Board.

He shall make disbursements in accordance with instructions duly transmitted to him in writing by the Secretary, such instructions to advise him of disbursements to be made in conformity with the provisions of these Articles of Association.

At the close of each fiscal year of THE ASSOCIATION, he shall cause his books to be audited for such fiscal year, by the Auditors appointed by the President, and he shall exhibit to the

Auditors all securities belonging to THE FOUNDATION.

At the time of the Annual Reunion he shall present to THE ASSOCIATION a written report of receipts and expenditures for the preceding fiscal year, and of the general condition of THE FOUNDATION, and shall file a copy of such report with the Secretary.

**The Trustees**

*Groups*

The Trustees shall be divided into five groups, selected by lot. The first group of three members shall serve for a period of one year; the second group of three members shall serve for a period of two years; the third group of three members shall serve for a period of three years; the fourth group of three members shall serve for a period of four years; and the fifth group of three members shall serve for a period of five years.

*Election*

At the time of the Preliminary Gathering each year, Trustees shall be elected by THE ASSOCIATION to replace those whose terms expire at the time of the Annual Reunion in that year. These Trustees shall serve for a period of five years, commencing at the conclusion of the business meeting at the time of the Annual Reunion, or until their successors shall be elected.

*Eligibility*

Only members shall be eligible to serve as Trustees and no Trustee who shall have served a full term of five years shall be eligible to reelection at the time such full term of five years shall expire.

*Vacancies*

A vacancy in the Board, either of Officer or Trustee, during the year for any cause shall be filled by election at the time of the next succeeding Preliminary Gathering or Annual Reunion of a special Officer or Trustee to complete the unexpired term caused by the vacancy, but the Board may elect an Officer or Trustee to fill any vacancy until the time of the next Preliminary Gathering or the next Annual Reunion.

**Property**

*Custodianship*

The Board shall have power and authority to receive by devise, bequest, or otherwise, and to

- Custodianship (cont.)* receipt for real estate and property of every sort; to accept, hold, buy, sell, rent and lease real estate; to receive, hold, buy, and sell personal property and securities and to deposit, invest, reinvest and dispense the same, all in accordance with the provisions of these Articles of Association.
- The Board shall have power and discretion to receive and to receipt for any gifts of any kind for any specific purpose and shall have the power to use such gifts for the purpose or purposes for which they may be given and designated.
- Investments* The Board shall have power and authority to invest and reinvest the funds of THE FOUNDATION, but no moneys shall be invested in securities which are not approved, designated and authorized by the laws of the State of Connecticut for the legal investment of Trust Funds, provided that THE FOUNDATION may receive and accept securities donated to it and when necessary shall convert same into cash or legal investments for Trust Funds as soon as it may be done conveniently, and further provided that the Board may, at its discretion, make loans to members, for the purpose of rendering assistance in such circumstances as the Board may deem it expedient to do so, loans to be repaid on terms approved by the Board and to bear such rate of interest as may be determined by the Board.
- Loans*
- Donations* The Board shall have power to make to a person, or persons, or to an organization, or organizations, donations or grants of money, intended to further any purpose, or purposes of THE FOUNDATION.
- Dispensing or Withdrawing Moneys* The signatures of any two Officers of the Board shall be required to dispense moneys or to withdraw money from any bank or depository. When the funds of THE FOUNDATION shall have reached the amount of Five Thousand Dollars (\$5000.00), each Officer shall be bonded at the expense of THE FOUNDATION in such sum as the Board may prescribe, for the faithful discharge of his duties.
- Bond*
- Meetings—Regular* Meetings of THE ASSOCIATION and of the Board shall be held at least twice a year, at the

- Meetings—  
Regular (cont.)* time of the Preliminary Gathering and of the Annual Reunion, respectively, at the place or places at which such meetings are held, the hour to be set by the President. The meetings of THE ASSOCIATION may be held simultaneously and concurrently with the business meetings of the Preliminary Gatherings and Annual Reunions, the President of the Skilton Family Organization presiding thereat, provided that the Secretary of THE ASSOCIATION shall make due record of all action taken which shall affect the affairs and interests of THE ASSOCIATION, and provided further that all action taken shall conform to the provisions of these Articles of Association insofar as THE ASSOCIATION and its affairs and interests are concerned.
- Meetings—  
Special* Special meetings of THE ASSOCIATION or of the Board may be called from time to time as the President may deem necessary or advisable or at the request of five Trustees duly communicated in writing to the Secretary. Unless otherwise specified in the call therefor, the place of a called meeting shall be in the State of Connecticut, and no meeting shall be called to assemble elsewhere than in the State of Connecticut, except upon the written request of not less than ten Trustees duly communicated in writing to the Secretary.
- Quorum* Five Trustees present either in person or proxy at any regular or special meeting of the Board duly called, shall constitute a quorum for the transaction of business.
- Notices* Notices of each regular and special meeting of the Board and of each special meeting of THE ASSOCIATION, shall be mailed at least one week prior to such meetings. Notices of Preliminary Gatherings or of Annual Reunions, sent by The Corresponding Secretary of The Skilton Family, shall be considered sufficient for the calling of regular meetings of THE ASSOCIATION.
- Proxies* Any Trustee may, by a writing, constitute an agent to vote in any meeting, but such proxy shall be valid only when given to a person who is a Trustee and shall entitle the person so authorized to vote only at such meeting.

- Voting by Ballot* All votes of the Board shall, if requested by any Trustee, be by ballot.
- Use of Net Income* During any fiscal year a sum not exceeding the net accrued income of THE FOUNDATION, excluding gifts, devises and bequests, may be employed under the direction of the Board in such manner as it may elect, or as THE ASSOCIATION may direct by formal vote duly recorded, for the furthering, promotion, encouragement and accomplishment of any object, project, or plan calculated or intended to carry out the purposes of THE FOUNDATION as specified in these Articles of Association, provided that any part of the principal may be loaned to a member or members as herein provided.
- Dispensing Moneys* Formal vote of the Board, duly recorded, or the written approval of a majority of the Trustees, or the approval of THE ASSOCIATION, by a formal vote at the time of any Preliminary Gathering or Annual Reunion, or Special Meeting, duly recorded, shall be required before dispensing moneys for any purpose or object, provided that no part of the principal may be expended without the consent of two thirds of those present and entitled to vote at a meeting of THE ASSOCIATION, and further provided that any loan to a member shall not be construed as expending the principal.
- Annual Report* A complete report of the doings of the Board shall be presented by the Secretary to THE ASSOCIATION at each Annual Reunion.
- Fiscal Year* The fiscal year of THE ASSOCIATION shall begin on the first day of August in each calendar year, and end on the thirty-first day of July in the succeeding calendar year.
- Amendment* Any proposed amendment to these Articles of Association shall be submitted in writing to THE ASSOCIATION assembled at the time of any Preliminary Gathering or Annual Reunion. If approved by two thirds of those present and entitled to vote at such meeting, it shall be referred to THE ASSOCIATION at the time of the next occurring Preliminary Gathering, or Annual Reunion, and shall become effective if approved by two thirds of those present and entitled to vote, provided that every proposed

- Amendment (cont.)* amendment shall receive not less than fifteen affirmative votes in at least one ballot before it be finally adopted and made effective.
- Dissolution* Upon the dissolution of THE ASSOCIATION, it shall select, or, if it fail to select, the Board shall select a Trust Company located and engaged in business in the State of Connecticut, to which shall be conveyed, transferred and delivered the net assets of THE FOUNDATION, to be held in trust by such Trust Company in perpetuity and to pay the net income from THE FOUNDATION to such person, or persons, or organization, or organizations, as THE ASSOCIATION may designate, for uses and purposes similar, or substantially similar, to those for which THE FOUNDATION is established. Should THE ASSOCIATION make no designation of person, or persons, or organization, or organizations, to receive such net income, the Board shall make such designation. Should both THE ASSOCIATION and the Board fail to make such designation of person, or persons, or organization, or organizations, to receive such net income, it shall be paid to the Town of Watertown, Connecticut, for uses and purposes similar, or substantially similar to those for which THE FOUNDATION is established.

The second undertaking is to edit and publish this Supplement.


### **The Skilton Plate**

At the fifty-ninth Annual Reunion of The Skilton Family, held at Watertown, Connecticut, August 20, 1924, a Committee, consisting of Ira Clifton Matteson, Joseph Isaac Riley and Edith May<sup>7</sup> Skilton, was appointed to secure the expression of the Family in regard to a "Skilton Plate". It was proposed that this be a Wedgwood plate, bearing a picture of the house built by Dr. Henry<sup>2</sup> Skilton, in Southington, Connecticut, between 1748 A.D. and 1760 A.D. (See page 10). As a result of the Committee's activities an order was placed for three hundred of the plates, which were received from England in January, 1926, the necessary expense being underwritten for the time being by several members of the Family. The plates were furnished either in blue or mulberry. The consignment was soon exhausted and a second order of ten dozen plates was received in August, 1926, which were also quickly sold.

Out of the profits accruing from the sale of the plates there was provided and turned over to The Doctor Henry Skilton Foundation the money to meet the cost of placing at the grave of Dr. Henry<sup>2</sup> Skilton, a bronze marker for a Revolutionary Soldier.

### **Marker for the Grave of Dr. Henry<sup>2</sup> Skilton**

This marker, in standard design to indicate the place of interment of a Revolutionary soldier, was unveiled at the grave of Dr. Henry<sup>2</sup> Skilton in the Old Cemetery, Watertown, Conn.,

immediately following the sixty-first Annual Reunion meeting on August 18, 1926.

Participated in by a considerable number of the Family and friends, the ceremony was simple and dignified, befitting the life and character of Dr. Henry<sup>2</sup> Skilton.

The Reverend Francis B. Whitcome, Rector of Christ Church, Watertown, Conn., offered an impressive prayer, at the close of which all united in repeating The Lord's Prayer.

"America" was sung under the leadership of Henry Irving<sup>7</sup> Skilton, who was in charge of the music.

Chloe Mariella<sup>7</sup> (Skilton) Myers read the following poem, composed for the occasion by Catharine Amanda<sup>7</sup> Skilton:

"We are told in song and story,  
 In records reverently kept,  
 Of heroic Henry Skilton,  
 Who for many years has slept  
 In the quiet of God's Acre,  
 In a small New England town,  
 Little dreaming of the glory  
 That has brought his name renown.  
 We here unveil this tablet,  
 That he who runs may read  
 The record of his service,  
 Of every patriotic deed.  
 To perpetuate his memory,  
 In reunion we are met,  
 That never shall a Skilton  
 Need to say, 'Lest we forget!'"

After the singing of "Oh, God! Our Help in Ages Past", Dr. John Davis<sup>7</sup> Skilton spoke appropriately of the marker, telling how it was secured, why it was being placed upon Dr. Henry<sup>2</sup> Skilton's grave and voicing sentiments of patriotism and appreciation of the Family's ancestral heritage.

At the conclusion of these remarks, the bronze tablet, which had been draped with the American Flag, surmounted by a brass eagle, was unveiled by Sperry Barnes<sup>8</sup> Skilton and Barbara Southmayd<sup>9</sup> Skilton. The assembled company sang The Star Spangled Banner and at the close of the exercises the Benediction was pronounced by Dr. John Davis<sup>7</sup> Skilton:

### **St. Michael's Cathedral Church**

The following article was obtained by 711 Catharine Amanda<sup>7</sup> Skilton on August 17, 1922, at St. Michael's Cathedral Church, Coventry, England. Perusal of it should give an added appre-

ciation of the dignity and splendor of the noble Church in whose Registers are preserved the earliest authentic records of the Family of Dr. Henry<sup>2</sup> Skilton.

"The present Church was built in place of earlier Norman and early English Churches at the close of the fourteenth century, the whole being completed within some 100 years, and representing the best type of perpendicular architecture. It is unique in its unity and simplicity. One of its chief glories is the nine storied steeple, six stories being taken up by the tower and lantern, and three by the spire. This is one of the finest in Europe, 300 feet high, corresponding to the length of the Church. The vaulting in the interior is nearly 100 feet from the floor.

"The width of the Church is abnormal, its area 22800 square feet, and it seats a congregation of 2000, all of whom have a practically uninterrupted view of the preacher. The flat low pitched roof makes the Church an admirable auditorium.

"The visitor will observe that the lines of the main building are out of straight, this being probably due to the fact that the choir and apse were first built, and that the extension of the Church to its present length in a straight line was rendered impossible by the adjoining St. Mary's Hall. The nave is of six bays, and the chancel of three, the arches being wide and the piers slight, a triumph of economy and technique in the adjustment of weight. The south porch is the oldest part of the Church.

"There were originally in pre-reformation times no less than eleven altars, most of them in Chapels belonging to the merchant guilds of the city. On the north side the Ladye Chapel, now used for daily services, was appropriated by the Drapers, that of St. Andrew on the north by the Smiths, and the east end of same by the Girdlers. Beyond the organ to the east, the south chancel aisle was the Chapel of the Mercers, and on the south, St. Thomas Chapel still appertains to the Cappers' Company, which meets annually in the Priests' chamber over the south porch. This Chapel has recently been renovated and screened off as a place of quiet devotion. In it will be found the ancient Cappers' Pall, also a small library of devotional literature. The Ancient Dyers' Chapel now forms the Baptistry. There are three founts, two of marble and one of stone; the oldest stands at the west end; that in the Baptistry is modern. Also a fine muniment chest outside the Ladye Chapel.

"The visitor will notice the costly and beautiful choir screens and Bishop's throne, recently given as a war memorial, and should inspect the old woodwork of the Ladye Chapel, where the ancient misericords of the Collegiate Church have been suitably placed. West of the Ladye Chapel is that of St. Lawrence, beneath which are two noble crypts. There are also

four communion tables of carved oak, one at least Jacobean, which deserve inspection.

"The principal monuments are those of Julian Nethermyl, at the west end, and the Swillingtons in the Mercers' Chapel, and an interesting epitaph self-composed to "an old tossed tennis ball", on the south wall.

"The ancient glass is fragmentary; the best of it has been gathered together in the two outer windows of the apse. The abundance of glass is a notable feature of the Church.

"The whole structure was restored 1885 to 1890, in red runcorn stone by Mr. J. O. Scott."

Amanda Jane Davis, oldest child of John Sowers Davis and Catharine Pasco (Nave) Davis, was b. She finished her scholastic education at Lagonda Institute, Springfield, Ohio, attaining at the same time a high degree of proficiency in music, both vocal and instrumental. She was for many years a communicant of Zion Church, Monroeville, and served for a long time as a member of the

Board of Managers of Gordon Cottage, Milan, one of the homes for ladies maintained by the Diocese of Ohio. She was a charter member of Althea Chapter, No. 438, Order of the Eastern Star.

Mrs. Skilton was an especially capable business woman, a keen judge of character, possessing remarkable intuition, having a marked streak of ingenuity, with an unusual knack of doing things herself, as well as a decided gift of enlisting the interest and energies of others. Hers was a delightful sense of humor. She had travelled extensively at home and abroad.

She ever bore well her part in life, meeting cheerfully and efficiently its responsibilities and enjoying its privileges and pleasures, being hospitable, open-handed and charitable, a good neighbor, an affectionate wife, a generous and unselfish mother.

She attained the age of eighty-one years, exactly one year younger than was her father, John Sowers Davis, at the time of his demise.

Mrs. Skilton was the great-grand-daughter of John Sowers III, a Revolutionary soldier, one of the two founders of Monroeville, who died in 1820. John Sowers III had one daughter, Mary Ann (Sowers) Davis, Mrs. Skilton's grandmother, and four sons. Descendants of all of these were present at Mrs. Skilton's obsequies, which were held May 22, 1925, at her home, Ingleside, a part of the original grant of land to John Sowers III, where she had resided more than two score years. Her body was placed in the family mausoleum in Riverside Cemetery by the side of her husband, the Committal Service being said by her only son, 708 John Davis' Skilton.

His whole character may be summarized in that he invariably adhered to the standard of "do unto others as you would they do unto you". Although not a member, he was a regular attendant at the services of the Methodist Episcopal Church, Cheshire, Conn.

That his quiet manner and honesty of purpose in life had endeared him to a host of warm friends was manifest by the numbers who gathered to pay their last tribute of respect to one of God's noblemen.

His fondness for music and his possession of a remarkably fine tenor voice led him to improve his talent in that line. He was fortunate in having as his teacher the Hon. Earle Buckingham, of Washington, who was regarded in those days as unsurpassed as a teacher in that part of the country. In the fall of 1883, he took up the same work as that of his teacher, and for 25 years he taught the old-fashioned singing school in Watertown and vicinity. His many pupils always spoke with pleasure of the hours spent under his instruction.

At an early age he joined the Methodist Episcopal Church in Watertown and entered heartily into all of its activities, holding the offices of steward, chorister and Sunday School teacher, until the failure of his health obliged him to seek a home in a warmer climate. In the winter of 1909 the family went to Florida, locating a year later in DeLand, where he occupied a responsible position with the firm of G. A. Dreka and Company.

He at once took a great interest in the life of the town, being instrumental in the establishment of the public library, treasurer of the Methodist Episcopal Church (North), treasurer of the Methodist Building Fund, secretary of the Citizen's League, secretary of the Men's Bible Union, and an officer in the Y.M.C.A.

Representing the highest type of Christian manhood, in his sterling worth, his high moral character and his lovable disposition, he set a high standard for himself and for others. He won friends wherever he went, both in his native town and in the state of his adoption.

Anna Mills (Peck) Skilton was of a fine, sensitive nature, intensely fond of poetry and music. She had in her young womanhood a soprano voice of unusual beauty and power. Both she and her husband were prominent in musical affairs in Watertown. She was an active member of the Methodist Episcopal Church, both in Watertown and in DeLand.
